**ORDER:**

The Director General of Police, Telangana State, Hyderabad, in the letter 3<sup>rd</sup> read above has submitted proposal for designating the Inspector General of Police/ Additional Director General of Police, Intelligence Department, Telangana State, Hyderabad as the Controlling Authority for the State of Telangana under sub-Section (1) of Section (3) of Private Security Agencies (Regulation) Act, 2005 (Central Act No.29 of 2005).

2. After careful examination of the matter, the Government have decided to designate the Inspector General of Police/Additional Director General of Police, Intelligence Department, Telangana State, Hyderabad as the Controlling Authority for the State of Telangana under sub-Section (1) of Section (3) of Private Security Agencies (Regulation) Act, 2005, with a view to strengthen the existing mechanism of enforcement of Private Security Agencies (Regulation) Act, 2005.

3. Accordingly, the Government hereby issue the following notification which shall be published in the extraordinary issue of the Telangana Gazette, dated:16.08.2022:-

**NOTIFICATION**

In exercise of the powers conferred under sub-Section (1) of Section (3) of Private Security Agencies (Regulation) Act, 2005 (Central Act No.29 of 2005), and all other powers hereunto enabling, the Government of Telangana hereby designate the Inspector General of Police/Additional Director General of Police, Intelligence Department, Telangana State, Hyderabad as the Controlling Authority for the State of Telangana for the purpose of said Act.
